The guarantee may be submitted in the form of a certificate of deposit naming the City of Grand Rapids as the owner, letter of credit from a financial institution approved by the City of Grand Rapids, or cashier’s check. The City will maintain possession of the Guarantee Fee until such time as the specific right-of-way restoration has been inspected and approved by the City of Grand Rapids Engineering Department.

In lieu of individual guarantees, the companies may submit an approved \$5,000 certificate of deposit naming the City of Grand Rapids as owner, letter of credit from a financial institution approved by the City of Grand Rapids or cashier’s check for each construction season beginning on May 15<sup>th</sup> of each year.

Review and processing fees

A one-time, non-refundable application fee of \$50.00 will be charged for individual permits issued. Any permits applied for after the fact will be charged double the application fee. This fee covers the cost of permit reviews and field inspections of rehabilitation sites.
