ARTS AND CULTURE COMMISSION MINUTES

CALL TO ORDER: Pursuant to due notice and call thereof the regular meeting of the Grand Rapids Arts and Culture Commission was held in Council Chambers at 420 N. Pokegama Avenue, Grand Rapids, Minnesota on Tuesday, February 2, 2021 at 4:03 PM.

<u>Call of Roll:</u> On a call of roll, the following members were present: Ed Zabinski, Kayla Aubid, Kari Hedlund, Myrna Peterson, Jennifer Gorman, Gail Otteson, Tom Sippola, Sonja Merrild, Anne-Marie Erickson. Absent: None.

Staff Present: Tom Pagel, Will Richter, Kimberly Gibeau

Public Input: None.

Setting the Agenda:

Motion by Peterson, second by Erickson to approve the agenda as presented. Motion passed by unanimous vote.

<u>Correspondence:</u> None.

Approval of Minutes:

Noted correction: spelling of Commissioner Hedlund last name.

Motion by Hedlund, second by Merrild to approve the minutes for November 10, 2020 with correction. Motion passed by unanimous vote.

<u>Financials:</u> Fund consists of \$5,924 roll over from 2020 budget and current annual budget of \$7,500, providing a total balance of \$13,424 for 2021.

Artist in Residence: Katie Marshall provided update on current happenings at the artist loft. David Dobbs has agreed to assume management responsibilities for program.

Old Business:

<u>Mapping Project:</u> Megan Christianson presented web application. Visit Grand Rapids will keep appupdated.

<u>Goodwin Art show</u>: Commissioner Aubid is working with Mr. Pagel, Commissioner Hedlund and Will Richter. Discussed idea for developing panels to place in front of areas throughout the city, pictures of artists work with descriptions. Perhaps working with local writers and poets to reflect on sculpture being worked on at Riverside Park and have those on panels also. Will continue to develop ideas and return with more information at March meeting.

Library Public Art Project:

Mr. Richter states that he is currently waiting for a fresh site specific proposal from artist Greg Mueller for a sculpture to be placed near trail and fishing pier. Library board prefers a piece that is specific to the library, perhaps a functional piece. Updates on art project will be provided as they are received.

New Business:

<u>Review of Art Plan:</u> Members are encouraged to become familiar with plan for year two public art and plan to work on goal setting at March meeting, keeping in mind that the revenue coming into capital fund will be lower in 2021 due to less road construction projects.

<u>City Email:</u> All City Boards and Commissions are transitioning to official City emails. IT Department will be contacting members to set up and will continue through end of service.

Announcements:

- City creating "Rapids Riverfest", to be held September 10 11, 2021. In planning process for entertainment and location. Would like to set up art village, a children's area and include as many area businesses and restaurants as possible. We will continue to monitor the Covid impact and event would be cancelled if necessary.
- City is working with "May Mobility." Limited art may be created for small areas near right-of-way.

Set a Solid Foundation for Arts and Cultural Recovery

Minnesota Citizens for the Arts (MCA) and its partners¹ are ready to enroll organizations, cities, counties, and regions for its next round of local economic studies. Let MCA provide you the tools you need to recover and grow your area's arts and cultural activity and economy.

MCA has conducted over 40 Creative Minnesota Economic Studies which have helped advocates achieve:

Over the past year, arts and cultural venues shuttered and in-person activities ceased. The impact of the global health pandemic has been devastating to the creative sector. Nationally, over 94% of artists and creative workers reported lost income². Arts and cultural nonprofits estimated financial loses at over \$10.2 billion. In Minnesota, 69% of arts and cultural nonprofits reported high levels of disruption due to the impacts of the pandemic and uprising³.

Amid the upset there are efforts to reassess and pivot to new practices, but we also know that this is an increasingly important sector, one that <u>outperformed</u> many other sectors in the recovery following the 2008 downturn.

Our economy relies more and more on creativity and innovation. Arts and culture are at the center of the growing knowledge economy where creative skills fuel the design and performance needs of the digital age in communications, marketing and promotions, and entertainment. A report by the Bureau of Economic Analysis (BEA) shows that in 2017, arts and cultural activity <u>outperformed</u> the transportation, construction, and agriculture industries⁴. Arts and culture contributed 4.5% of gross domestic product, or \$877.8 billion,




Preliminary Public Art Proposal Revision: Bike Rack


CREATIVE INFLUENCE: Vessel Bike Rack Sculpture

- Historically the Birchbark canoe provided transport throughout Northern Minnesota's waterways, and its unique architecture, such as the hulls, have intriguing sculptural qualities.
- Indigenous translations of Pokegama Lake "...water which juts off from another water...the lake with bays branching out..."
- Vessels are a tool of exploration and discovery, much like the Grand Rapids Area Library


SITE and CONTEXT: BIKING RECREATION AND GRAND RAPIDS LIBRARY PUBLIC TRAIL









DETAIL DRAWING 1: VESSEL FORM AS FUNCTIONAL PUBLIC ART





DETAIL DRAWING 2: VESSEL BIKE RACK CONCEPT




DETAIL DRAWING 3: VESSEL BIKE RACK CONCEPT

3" diam hull / tree trunk: powder-coated steel tube


1" diam. - 2.5" diam. varied stainless tree branch forms




DETAIL DRAWING 1: BIKE RACK SPACING








CONSTUCTION: DRAWING 1







MATERIALS: - "tree trunk/vessel hulls" pipe bending of 1/4" thick pipe

- birch branches composed of 1/4" thick half pipe scroll forms

- panels would include slit cuts - "lenticels"

CONSTRUCTION NOTES: each tree/vessel hull anchored into concrete pad

Anchor Body—available in zinc-plated steel, hot-dipped galvanized steel, 304 stainless steel and 316 stainless steel








