#### ARTS AND CULTURE COMMISSION MINUTES

**CALL TO ORDER:** Pursuant to due notice and call thereof the regular meeting of the Grand Rapids Arts and Culture Commission was held in Conference Room 2A of the Grand Rapids City Hall, 420 N. Pokegama Avenue, Grand Rapids, Minnesota on Tuesday, January 14, 2020 at 3:45 PM.

<u>Call of Roll:</u> On a call of roll, the following members were present: Anne-Marie Erickson, David Marty, Jessie Siiter, Gail Otteson, Tom Sippola, Kayla Aubid, Kari Hedlund, Myrna Peterson (virtual presence) and Ed Zabinski (arrived at 4:06 PM). Absent: None.

Administrator Tom Pagel called the meeting to order.

**Public:** None.

#### **Setting the Agenda:**

Motion by Aubid, second by Smith to approve the agenda as presented. Motion passed by unanimous vote.

#### **Election of Officers:**

The first meeting of the year requires election of Chair, Vice-Chair and Secretary.

Motion by Erickson, second by Otteson nominating Ed Zabinski as Chair for 2020. Motion passed by unanimous vote.

Motion by Marty, second by Aubid nominating Anne-Marie Erickson as Vice-Chair for 2020. Motion passed by unanimous vote.

Motion by Marty, second by Erickson nominating Jessie Silter as Secretary for 2020. Motion passed by unanimous vote.

Vice-Chair Erickson presided over the meeting in the absence of Chair Zabinski.

**Correspondence:** None.

#### **Approval of Minutes:**

Motion by Marty, second by Hedlund to approve the minutes for December 3, 2019 as presented. Motion passed by unanimous vote.

**<u>Financials:</u>** Reviewed financials for end of 2019. Noted that the new operating budget for 2020 is \$7,500.00.

<u>Artist in Residence:</u> There is currently one new applicant for the next series. Possibility for current residents to apply for next series.

#### **New Business:**

Chair Zabinski arrived at 4:06 pm and presided over the remainder of the meeting.

#### Discuss organizing public forum on Public Art:

Sonja Merrild reviewed work with Forecast Public Art and final piece of contract to hold a public forum with the community. Discussed possible collaboration with Grand Rapids Arts Fair in July 2020 or combining with a First Friday Art Walk. Commissioner Aubid will look at different options and come back to group with suggestions.

#### **Old Business:**

#### <u>Discuss Northbank mural project, Grant discussion and Kiosk:</u>

Still working on these items. Changemaker Retreat grant was approved for \$1200. John Thunder, Artist, is interested in working with MacRostie and Thisledew, Department of Corrections on a project working with incarcerated individuals, connecting them with surrounding communities prior to release.

<u>Mayor's Arts Award:</u> Has been publicly announced and accepting applications. Discussed selection process and concerns about possible conflict of interest with members associated with nominees. Questions regarding criteria and need to clarify the policy. Staff will follow up. The Commission has a budget of \$300 earmarked for the award and this will be presented in April 2020 to the recipient. Deadline is set for January 31, 2020 and nominations received will be brought to the February 4<sup>th</sup> meeting for review.

## **New Business (continued):**

<u>Discuss recommendations for 2020 Public Art:</u> Subcommittee consisting of Commissioners Aubid, Hedlund, Zabinski and Administrator Tom Pagel present recommendations. Following discussion, Mr. Pagel will draft a request for qualifications for consideration. If approved, the request will be forwarded to the City Council for authorization. The process will follow the map set out by Forecast Public Art in the search for sculptors and muralist from last year. Members overall preference is for one large sculpture opposed to two smaller pieces.

## The Mayor's Arts Award

The Mayor's Arts Award will be granted to a Grand Rapids area business, organization, or an individual that supports and promotes local arts organizations, programs or individual artists through funding, advocacy and/or community outreach in the Grand Rapids area.

#### **Eligibility Guidelines:**

- Businesses, organizations, or an individual may be nominated or may nominate themselves by sending a letter of nomination to the Grand Rapids Arts and Culture Commission, 420 N. Pokegama Avenue, Grand Rapids MN 55744 as described below.
- Businesses, organizations, or individuals must be located in, or a resident of, the City of Grand Rapids.
- The Grand Rapids Arts and Culture Committee will identify a winning nomination, or more than one nomination if the Committee deems fit, and forward their recommendation(s) to the City Council for their consideration at a February City Council Meeting.
- Winners will be personally notified prior to the award ceremony.
- Telephone nominations will not be accepted.
- Questions concerning this award may be directed to Amy Dettmer (adettmer@ci.grand-rapids.mn.us), or the City Clerk in her absence.

### Timeline and Selection:

- A press release calling for nominations will be advertised by January 1<sup>st</sup> of every calendar year. Notice of the same will be advertised in the *Grand Rapids Herald Review*, or other designated legal publication, at least twice prior to the nominations deadline closing. The notice will also be posted on the City's website and physically placed upon the public notice board at City Hall during the same timeframe.
- Deadline for nominations are February 1<sup>st</sup> of every year.

- Letters of nomination will be reviewed at the Grand Rapids Arts and Culture Committee's February meeting.
- The Grand Rapids Arts and Culture Committee will identify a winning nomination, or more than one nomination if the Committee deems fit, and forward their recommendation to the City Council for their consideration at a February City Council Meeting.
- The award will be presented at the Grand Rapids Chamber of Commerce Annual Dinner.
- The award will consist of a donated item of art or other item of artistic significance, or a physical award highlighting the Mayor's appreciation of the business's, organization's, or an individual's efforts in promoting the arts in the City of Grand Rapids.

Mayor's Arts Award nomination letter January 14, 2020

Dear Grand Rapids Arts and Culture Commission,


I would like to nominate Project Care Free Clinic of Grand Rapids and Site Coordinator Pam Dowell for consideration for the Mayor's Arts Award. I work as a paramedic in Grand Rapids and I am an enthusiastic volunteer for Project Care Free Clinic.

About eight years ago, I ended up in this northwoods milltown, mostly by accident. Since then I have found a real feeling of home here, and have become engaged in the community on a number of fronts, including with the homeless and the uninsured. It's easy to see the effect that the arts have on making Grand Rapids one of the brightest places on the Iron Range and in Minnesota's north woods and lakes more broadly. From my point of view, Pam Dowell's work at Project Care Free Clinic has been marvelous addition to the arts, culture and health of Grand Rapids. As someone involved in healthcare, and with an interest in being part of healthy communities, it's not hard to see the benefit that living in a place where art and creativity are valued and encouraged, provides to all segments of the community.

Pam became the manager of the local branch of Project Care Free Clinic about four years ago. One of her first initiatives was to have Project Care become a stop in the First Friday Art Walk. This way Pam was able to support the arts locally by bringing in little known local artists to exhibit at the downtown clinic. I recognize that awards and recognition often go to large benefactors and agents who have significant financial resources to contribute. While such major financial commitments are laudatory and are often a factor in supporting local art, I think it is also vital to recognize the significant contributions of time, resources and energy that are put forth by enthusiastic backers of the arts who are of more limited financial means.

Under Pam's direction and leadership, multiple and varied artists who were otherwise little known in this area have found a venue to gain exposure and display their work. On many First Fridays, several artists are presenting their works at Project Care Free Clinic. Sometimes, additional tent space had been needed to house the variety of artists and musicians presenting/performing at Project Care Free Clinic, who couldn't be contained inside the clinic building itself.

When Pam was new to her role at Project Care, she was concerned about the façade of the Free Clinic, and before several large grant funded projects aided in the downtown beautification, Pam, with her own funds and time, went to work enhancing the clinic façade with bold, bright colors and a hand-painted logo applied by local folk artist and former New Orleanian Patti Farrell.



Pam has been a huge supporter, & often benefactor for Patti Farrell. Patti moved to the Grand Rapids area in 2015 from New Orleans and knew very few people here. Pam saw Patti's art and encouraged her to reach out to the local arts community. Patti quickly became an artist in residence at the Central School. Project Care has hosted Patti as a consistent artist and exhibitor. Patti's clientele has grown and she has been able to exhibit her work at a number of Grand Rapids locations, and as a result has had a number of pieces commissioned. Pam herself has commissioned Patti to do special art pieces, including a memorial piece that was dedicated to the family of Bernice Kane, a nurse practitioner and volunteer at Project Care, who passed away two years ago in a tragic accident. Patti is now an artist assistant with Itasca Life Options coaching and instructing clients in art exercises and activities.

Project Care Free Clinic is a non-profit free clinic that receives no state or federal funding. It runs on donations and grants, with an extremely limited budget, and is staffed by volunteers who are committed to providing service to the uninsured in our community. Pam's mother, Jackie Dowell, pays the First Friday fees and Pam supplies all the added advertising, food, refreshments and marketing for the events out of her own pocket. Pam is very conscious of human rights issues and health care advocacy, so part of the art awareness will often be centered on social justice causes. The first Project Care open house introduced the area to the artworks of Shephard Fairey, a well-known street graphic artist based out of California. Pam was able to secure many prints from his series, including an autographed piece. She was also able to get some added pieces from his apprentice Ernesto Yerena.

In another exhibit, Project Care went out to the community, Kiesler Wellness Center and a local daycare and asked for children and adults in a wellness class to contribute art for an exhibit called, "The Healers." Pam provided the canvases and papers for the artists, and a wonderful body of work was created that focused on children's interpretations of "the difference makers" in their community. Each Kiesler participant painted or created a piece that spoke to art as healing.

This past year Pam happened upon two octogenarian home artists and offered them the opportunity to exhibit. These ladies were thrilled as they never thought of themselves as "artists." They were both very unassuming and knew little about the local arts in Grand Rapids. After their exhibits at Project Care, both women have been invited to show in other locations. It is heartwarming to see these initiatives by a local small business/individual result in increased energy, excitement and AWARENESS of local arts in the downtown area. Pam typically purchases a piece of art from the clinic 1st Friday artists, and has created a permanent collection at Project Care Free Clinic. It has been gratifying to see patients come in and admire the art on the clinic walls. It has also been a great way to learn about unknown artists. It is

often a patient or patient attendee who will tell Pam about a little known artist in the area, and Pam will reach out to them.

I also think the clinic is a particularly comfortable location for the exhibiting artists, as it is not a retail establishment and hence, the focus is solely on the artist's work. Each exhibitor has their own room and space, which creates a more personal venue for the public to engage with the artists. I am a regular attendee and supporter of the First Friday Art Walk. I appreciate that Project Care Free Clinic supports the downtown arts and promotes art as an avenue for better health and a stronger community. So, I present this nomination of a small, non-profit, free healthcare clinic, because I believe that art and creativity undoubtedly help the physical, mental, and emotional well-being of the community the clinic serves.

I would like to nominate Grand Itasca Clinic and Hospital for the 2019 Mayor's Arts Award.

My name is Tyler Waller and I am the Inpatient Pharmacy Manager at Grand Itasca Clinic and Hospital. I have had the great pleasure of working at Grand Itasca for nearly 9 years and was able to participate in the planning and development of Grand Itasca's new Infusion and Cancer center. We are an incredibly lucky facility to have such a beautiful space to work and take care of our patients in. While the space and infrastructure are amazing- it was apparent early that the space would need art to bring it warmth and truly make it a space for healing.

The first installation put in this new space was the 2017 "Close to Home" capital campaign donor wall, designed and constructed by local artist Aaron Squadroni. This piece immediately brought the lobby to life and provided a way for donors to memorialize their loved one(s) and their commitment to cancer care. The artist continued and showcased the earth-tone theme that Grand Itasca is known for.

As an employee in this space, I noticed that it wasn't long before Grand Itasca had other beautiful pieces installed for our patients (and employees) to enjoy. Pieces by local artists such as: Charles Beck, Bob Carls, John Connelly, Dorothy Hall, Glenna Olson, Mike and Kathy Jasper, Reuben Patnaude, Karlyn Berg, Susan Clandon, Jane Latimer and Keith Thompson. It is my understanding that Grand Itasca invested nearly \$25,000 to bring this space to life and it shows.

While the Infusion and Cancer Center has been the most recent commitment to art, it is certainly not the only example. Grand Itasca's Professional Building annually adds art created by our pediatric patients to its clinic lobby. This art is created as part of the annual collection created to be auctioned off at the Burggraf's ACE Hardware Caring Fore Kids Charity Classic. What a wonderful way to have this population represented in our community.

As I walk the hallways of my work-place, I am so grateful for the time and effort put it into making it a beautiful place. Our patients come to us during some of the hardest days of their life- this organizations commitment to making this space a beautiful place to heal is just another way that Grand Itasca strives for patient-centered excellence.

Dear Grand Rapids Arts and Culture Commission:

I am writing to nominate Grand Itasca Clinic and Hospital (GICH) for the Mayor's Arts Award. GICH is well deserving of this award for many reasons including:

- All artwork at Grand Itasca is high quality work from Minnesota artists with an emphasis on local artists.
- GICH entire facility has design elements that support a healing environment; the art collection is an additional investment in demonstrating commitment to art as a part of GICH's healing philosophy.
- Through GICH's permanent art collection, Grand Itasca has invested significant dollars in our community's creative economy by paying working artists for their work. Most recently spending \$25,000 to purchase over 40 new pieces for GICH's newly remodeled space including: Unit 5 in the clinic, the Oncology clinic and the infusion center.
- All artwork is also framed locally, again investing in local business.
- Local artists on display at Grand Itasca include: Charles Beck, Bob Carls, John Connelly,
  Dorothy Hall, Glenna Olson, Mike and Kathy Jasper, Reuben Patnaude, Karlyn Berg, Susan
  Clandon, Jane Latimer, Aaron Squadroni, and Keith Thompson. Among these names you will
  find artists recognized by the McKnight Foundation, the Minnesota State Arts Board, and the
  Arrowhead Regional Arts Council.
- At Grand Itasca, the facility and artwork have been designed and selected to represent nature and the significant role it plays in the art of healing. When acquiring artwork, GICH has engaged a panel of community members with knowledge, experience and differing viewpoints in artwork to assist in the selection process.
- The GICH donor walls also demonstrate Grand Itasca's passion and investment in local art.
  - The 2005 "My Health, Our Future" donor wall recognizes donors who generously supported the original build of this new campus on Golf Course Road. The donor wall was designed and constructed by local artists with the intention to support and honor local donors along with local resources. Elements used on this donor wall include: wood for forests, glass for water and beautiful copper for local metals and resources found in our community.
  - Annually, Bob Carls and Amy Sharpe design and hand engrave the Foundation Fever –
    Employee Giving Campaign donor wall. On its 9<sup>th</sup> year of existence, this campaign allows
    for an annual addition to the recognition of donors and growth of Grand Itasca's art
    collection.
  - And most recently, the 2017 "Close to Home" capital campaign donor wall, designed and constructed by Aaron Squadroni, continues GICH's legacy of honoring the earth tones of our region all while recognizing community donors who helped bring a new cancer clinic and infusion center to our community. This donor wall is another symbol of Grand Itasca's significant commitment to the beauty of artwork throughout our entire facility.

- Grand Itasca Clinic and Hospital has a continued commitment to the arts in our community: The plan for 2019 is to bring an outdoor labyrinth and healing garden to the campus. This project is being led by Grand Itasca Foundation in partnership with a community committee who are committed to expanding Grand Itasca's commitment to art and nature. The healing garden will be an outdoor space built as an extension of GICH's indoor artwork collection.
- Located at Grand Itasca's Professional Building, artwork created by Grand Itasca pediatric patients is annually added to that clinic lobby collection. Each year this original artwork is created by the pediatric patients who help Grand Itasca Foundation promote their largest fundraiser, the Burggraf's Ace Hardware Caring Fore Kids Charity Classic. The artwork project was created and is led annually by Foundation Board Member and Burggraf's Ace Hardware Store Owner, Amber Burggraf. The artwork is designed by pediatric patients and auctioned off at the event each year. Since the project began three years ago, the highest bidder who won the artwork at the charity event has then donated it back to the clinic & hospital to be displayed in the lobby at the Pro Building for all of GICH pediatric rehab patients to enjoy.

I am in my second term serving on the Arrowhead Regional Arts Council, in the past years I have spent a lot of time reviewing grant applications, projects and resumes. Grand Itasca Clinic and Hospital sets the bar high when it comes to the thoughtful process used to select art for its campuses, the investment in quality artwork and for creating beautiful healing spaces.

Please accept the following as a support letter for the nomination of Grand Itasca Clinic and Hospital for the current Mayor's Award through the Arts and Culture Commission. I note that in your Arts and Culture Commission Roadmap you state that Grand Itasca promotes "links between art and healing." It is this art of healing work at Grand Itasca that I am supporting for this award.

I have had the pleasure of working on this program at Grand Itasca as a volunteer community member before the new facility was built and through the current new remodeling for the cancer and infusion center. I was co-chair of the building committee for the new hospital and a board member of the facility so had a role in decisions about the selection of final furnishings for the new facility. We put together a small team of volunteers to work with area artists to bring art and healing together. We knew that beautiful architecture, natural lighting and the creative work of area artists could and would create an atmosphere for healing in the new hospital and clinic. More than 30 local and regional artists answered our call for original art. Patients and their families who spend time at Grand Itasca have told me many, many times through the years that their stay has been positively impacted by being surrounded by beautiful art as they journeyed through the healing process.

So when the new cancer and infusion center was completed this past year, once again it was a natural process to encourage local artists to submit original art in a variety of forms for the new healing space. Our team of community volunteers and Grand Itasca staff strongly believe that people heal when they are surrounded by caring people, good medicine and beauty, both though art and nature. We once again had a total art budget of \$25,000 for the purchase and framing of local art. The number of artists and quality of their work was exceptional and will once again help future patients, families and caregivers work together for better healthcare outcomes. Our next projects will be to complete a healing garden and labyrinth project at Grand Itasca in the next few months to continue these art of healing outcomes.

This ongoing partnership between local artists and the health care community is yet another example of art working to build a more caring, healing community. Thank you for your consideration of Grand Itasca for the this Mayor's Award this year.

It is with great pleasure that we nominate KAXE Northern Community Radio for consideration for the 2019 Mayor's Art Award. In addition to playing a vast variety of music daily that caters to a wide-ranging audience of listeners, KAXE has a longstanding commitment to and history of highlighting, promoting, influencing and supporting local art.

As listeners and members of KAXE, we have come to rely on the station for information and promotion of arts in our area and value the fact that they intentionally do so in collaboration with other area non-profits that are also committed to local art.

For example, KAXE, in collaboration with MacRostie Art Center, provides monthly promotion of the 1<sup>st</sup> Friday artists which includes a variety of art mediums such as authors, potters, painters, musicians, and more. They also partner with the Reif Center on a program called CenterStage Minnesota – a monthly concert, which is open to the public and showcases the talents of Minnesota musicians. Also, the station provides on-air art interviews at least twice per week.

This year the Arts and Culture Commission will commission temporary pavement art that will last two to four years and will highlight storm and sanitary sewer catch basins/manholes and enhance traditional crosswalks and future curb "bump outs." 
