## Creative Community Builders with Tom Borrup and Peter Musty Metris Arts Consulting with Anne Gadwa Nicodemus

The Commission presented the following consultant interview questions. Each question was followed up by consultant's response.

1. Public engagement process is critical to the Commission and other civic leaders in Grand Rapids. You have outlined several suggested steps for public engagement in your proposal. Please tell us more about your underlying rationale and why this process works well.

2. How will this process help Grand Rapids learn new information and go beyond what we bready know? Please share examples of your work with other similar communities.

3. Working with the Commission would presumably happen alongside your other projects. How does this work fit the schedule of the individuals you have assigned to this project? Will they be able to devote the necessary time on the ground?

4. The Commission asked for a creation of a 10-year plan. What are your suggestions for phasing the plan, given its long timeline?

5. Please share examples of obstacles encountered in past similar projects and how they were overcome.

6. Many plans are made in the public realm and citizens often criticize public leaders for planning and not executing – i.e. the plan sits on a shelf. How will our engagement with you and the specific plan design ensure the plan is executable?

7. How do cultural plans traditionally mesh with a city's comprehensive plan?

8. What do you see as the differences between rural and urban arts?

9. What do you find unique about our area that could be defined as regional flavor?

. Do we have wiggle room with the timeline you proposed?

11. In addition to what you shared with us in your proposal, what else should the Commission know about your and your team's approach and work? Why would your team be best suited to carry out this work?

Each group was thanked for traveling to Grand Rapids and that a decision would be made within a week to let the consultants know the decision made by the Commission.

A discussion was held regarding the two consultants.


## **RECOMMENDATION OF METRIS CONSULTING**

Location of the opening will be at the Grand Rapids City Hall, 420 North Pokegama Avenue, Grand Rapids MN 55744.

#### INTENT

Rapids, population 10,869 (2010 Census), is located on the banks of the Mississippi River and is the seat of County in northeastern Minnesota. Situated among 1,000 lakes, it is also the economic and cultural center for thousands who live just beyond the city's borders. The city is home to many nonprofit arts organizations including two choruses, a symphony orchestra, student dance and strings programs, several galleries, a community theater, a community radio and television station and a major performing arts center. Itasca Community College, UPM Blandin Paper, Grand Itasca Clinic & Hospital, School District 318 and Blandin Foundation are major employers that make a significant impact on the community. Fifteen miles west lies the edge of the Leech Lake Band of Ojibwa Reservation.

The City is requesting proposals from a consultant/firm to develop a ten year strategic Arts and Culture Plan. The plan will give direction to the City in setting policy and allotting resources in matters pertaining to municipal arts and culture. The plan must recognize the role diversity plays in a creative economy by highlighting the importance of people of various backgrounds, ages, abilities and personal orientations.

Inventory existing arts spaces, venues and public art.

#### Phase Two: Goal Setting and Plan Development

- I. Develop and prioritize goals, objectives, and strategies with the Arts and Culture Commission.
- II. Identify with the Arts and Culture Commission four to five key areas of focus.
- III. Develop an action plan identifying responsibilities for implementing the plan in the following areas:
  - A. Marketing the plan to the community
  - B. Private and public funding for implementation
  - C. Assessing outcomes
  - D. Monitoring strategies and goals
- IV. Clarify roles of City commissions and committees and staff.
- V. Prepare a sufficient cost analysis for proposed Cultural Plan.
- YL Present the Cultural Plan at a minimum of 3 open meetings in Grand Rapids prior to adoption.

Proposal must include consultant qualifications, how work will be performed, statement of costs and 3 references. Proposals must be received at the City of Grand Rapids Administration Department, 420 N Pokegama Avenue, Grand Rapids MN 55744 no later than 4:30 pm CST, February 28, 2014.
