Background Information:

With the upcoming retirement of Fire Chief Steve Flaherty, we would like to bring in a Leadership Consultant to assist the incoming Fire Chief in the transition. Dale Rosier, former Fire Chief for the Grand Rapids Fire Department, has offered to assist during this transition. Dale brings a wealth of knowledge in leadership development with his education and experience. Dale will provide feedback to the City Administrator during the introductory period of the new Fire Chief.

Staff Recommendation:
