Honeywell Updated Project Development Agreement

Project Development Agreement (PDA)

City of Grand Rapids 420 N. Pokegama Avenue Grand Rapids, MN 55744 Honeywell 1985 Douglas Drive N Golden Valley, Minnesota 55422

Honeywell agrees to undertake a Comprehensive Facility Analysis of the City of Grand Rapids Facilities as identified on page 2.

This analysis will determine the energy consumption and operational characteristics of the facilities and will identify the energy efficiency measures, facility improvements, utility procurement alternatives and operating and efficiency procedures that will reduce the City of Grand Rapids' energy and operating costs, and reduce planned capital dollars.

The City of Grand Rapids intends to negotiate a contract with Honeywell utilizing MN Statute 471.345 which provides a framework for a guaranteed energy savings project. The City of Grand Rapids intends to negotiate with Honeywell in good faith and will execute a contract if Honeywell can provide the necessary documentation to meet the following objectives:

- 1. Provide a list of specific energy efficiency measures, indoor air quality improvements, deferred maintenance, ventilation needs, infrastructure solutions and other facility improvements that Honeywell proposes to implement.
- 2. Provide a description of the operating and maintenance procedures that will reduce the energy and operating costs of the facilities.
- 3. Identify the energy and operating costs that will be saved by the proposed improvements and procedures at the facilities.
- 4. Identify any alternative utility procurement strategies that will reduce the unit cost of utilities at the facilities.
- 5. Identify the costs for implementing the proposed improvements and procedures recommended.
- 6. Provide a cash flow analysis that identifies how the cost for the recommended program will be paid for with energy and operating savings, and other approved funding mechanisms generated by the reported recommendations.

If Honeywell is unable to deliver a report that meets the aforementioned objectives, the City of Grand Rapids will have the option to cancel this agreement with Honeywell and will incur no cost. In addition, Honeywell will provide an initial assessment to the Council at the Work Session on August 13, 2012. The assessment will validate the opportunity provided in the preliminary study completed March 2012 to determine the viability, or lack thereof, to continue with the Comprehensive Audit. If either party determines there is not sufficient merit to continue with the complete audit, the contract may be cancelled. The City of Grand Rapids would not incur any cost.

If Honeywell is able to deliver a report that does meet the aforementioned objectives and City of Grand Rapids elects not to enter into an agreement with Honeywell, the City of Grand Rapids will be obligated to reimburse Honeywell \$29,000 for the costs they incurred performing the Comprehensive Facility Analysis.

If after reviewing Honeywell's final Comprehensive Facility Analysis report, the City of Grand Rapids enters into an agreement with Honeywell to implement the proposed recommendations, the actual cost for the Comprehensive Facility Analysis will be included in the total program.
