Consider authorizing the Executive Director's approval of a Program Related Investment Agreement and Non-Recourse Promissory Note with the Blandin Foundation. At their 2019 fall meeting, the Foundation Board approved GREDA's request to re-establish the PRI, in the same amount, with some new revisions. The Redevelopment Fund will be available for a period of 10 years with GREDA draws permitting in the first five years and repayment complete by the end of 2029. The interest rate on these loans will range between 0% and .25% above Prime Rate, depending on the specific use of the Fund. Kennedy and Graven in is the process of reviewing the agreement.

MOTION BY COMMISSIONER CHRISTY, SECOND BY COMMISSIONER JACKSON TO AUTHORIZE EXECUTIVE DIRECTOR'S APPROVAL OF A PROGRAM RELATED INVESTMENT AGREEMENT AND NON-RECOURSE PROMISSORY NOTE WITH THE BLANDIN FOUNDATION SHOULD THE ATTORNEY NOT HAVE ANY SUBSTINATE CHANGES. Unique Opportunities- They have submitted their TIF application for a 48 unit apartment building to be built on the lot off of SE 21st Street.

Former Ainsworth Site- There is about 2.5 million in costs to bring utilities to the site.

Sawmill Site- The developers have received interest in one of the commercial lots.

The Pillars- The rezoning request was approved by the Planning Commission and will be on the agenda at the next City Council meeting for final approval. They are hoping to break ground in June.
