CALL TO ORDER: Pursuant to due notice and call thereof a regular meeting of the Grand Rapids Human Rights Commission was held in Council Chambers, Grand Rapids City Hall, Grand Rapids, Minnesota, on Wednesday, December 30, 2020 at 4:00 p.m.

Data and Demographic Work Group – Memo to City of Grand Rapids Human Rights Commission, January 2021

The data and demographic work group was created by the Human Rights Commission for the City of Grand Rapids to:

- Gather or develop demographic data. From this data we are to identify the most significant human rights concerns in our community, and
- Develop strategies, activities, and policy recommendations to address said concerns.

The work group utilized several sources to review data and demographics for Grand Rapids and surrounding area, including:

After reviewing the data, this work group recommends to the Human Rights Commission to further investigate two areas of interest:

- Disability defined as including, but not limited to: hearing, vision, cognitive, ambulatory, self-care, independent living difficulties
 - o 19.6% of City of Grand Rapids population has a disability (MN Compass, n.d.-b).
 - This is higher than what is reported at both the Northland Region and state level, at 17.4% and 11% respectively
- Housing access, issues
 - o 25% of households in poverty reported that housing that is safe to live in was a problem (Kootasca, n.d.)
 - 26% of those who were homeless, were homeless more than one year (Kootasca, n.d.)

One additional observation that was noted within the work group was that the members approached and considered Grand Rapids as a city to not be an "island" – and reflecting on how the City exists within the larger context of the county, region, and state are important considerations.

The work group suggests these two areas of human rights interest (disability and housing) for further study during 2021 especially as they relate to protected areas as defined by state law and because they relate to the quality of life in Grand Rapids.

To further investigate, this work group recommends looking into additional data sources to see what the data says or suggests about the issues of disability and housing in our community, and to see what opportunities exist for the Human Rights Commission as it may relate to activities or policy/action recommendations to the City of Grand Rapids. The work group would like to contact City Administration to determine if City Staff resources could be used to assemble this additional data.
