<u>CALL TO ORDER</u> The meeting was called to order 4:00 pm by vice-chair Sanderson.

APPROVAL OF MINUTES April 29, 2015 Regular Meeting

MOTION BY COMMISSIONER DOWELL, SECOND BY COMMISSIONER MOREN TO APPROVE THE MINUTES OF APRIL 29, 2015 with the following corrections:

At the bottom of page 1 where City Administrator Pagel spoke of the City of Grand Rapids introducing a new ADA Sub Committee; Commissioner's Sanderson, Schirber and Moren would like to be part of the ADA sub-committee once it becomes established. **Motion passed by unanimous vote**

For the benefit of the new members, Commissioner Sanderson explained the role of the Commission. When there are problems/complaints that should arise these should be directed to the Minnesota Department of Human Rights.

OLD BUSINESS

INDIGENOUS PEOPLE'S DAY

Commissioner Sanderson reported that the committee is putting together the activities surrounding indigenous people's day on October 12. There will be music, dance, refreshments, and an educational component. The next meeting will be held on June 15 at 4:00 pm. Anyone is invited to attend. A notice of quorum will be posted.

TRACKS IN THE SNOW

Commissioner Learmont reported that the exhibit is traveling to outstate Minnesota as well as being displayed in the Twin Cities. The preferred location suggested earlier by the Commission is at the Grand Rapids Public Library. There are 25 panels each with a picture and description plus some large banners. Co-sponsors need to be identified for this project and possible other activities or events to be associated with the exhibit. The library program committee will be meeting soon to look at their schedule and display space issues and there will be a report to the Commission as details are clarified."

BUKATA HAYES

Commissioner Sanderson reported that Bukata Hayes is scheduled to come to the Timber Lake on September 17 with a breakfast at no cost. The Blandin Foundation has agreed to sponsor part of this event and the program committee will be working with the Chamber for other possible sponsors. There is some flexibility to possibly have him speak at the College depending upon availability. Commissioner Noyce will work with ICC to see if there is something that can be worked for the college students.

NEW BUSINESS

HUMAN RIGHTS OFFICE – DULUTH

Commissioner Sanderson reported briefly regarding the need to have a Human Rights Office in Northern Minnesota. There is a request for the Minnesota Department of Human Rights open an office in Duluth. Duluth Human Rights Commission is seeking support to make this request happen. If the Human Rights Commission would favor this they would like a letter of support.


Selected Student Comments

After exposure to "Why Treaties Matter" and related programing, I feel my familiarity with treaties has increased



Lessons Learned (so far)

- Indian Ed staff stepped up in a huge way to prepare for and make use of the exhibition while it was at their schools.
- There is a willingness to include the topic of Native treaties into lesson plans if resources are made available to district faculty.
- Programming supporting the exhibit reinforces the importance of the topic area.
- Consistency in collecting data is both a challenge and opportunity.
