Dear Representative Howe,

For the past several months, Leech Lake Tribal Court Judge Korey Wahwassuck has served as a liaison between Chairwoman Carri Jones and the *Circle of Healing*, a group of area residents working to find new ways to build relationships between Ojibwe and non-native people of our area. Please see the attached fact sheet for more information about the group. The Blandin Foundation supports, and several staff members including myself participate in this group. Because Judge Wahwassuck is transitioning to Itasca County, I have been asked to be Chairwoman Jones' liaison, which I am happy to do.

On Thursday, September 12, 2013 from 10:00 am to noon, we are planning to install the Leech Lake Band of Ojibwe flag at two locations in Grand Rapids – in front the Itasca County Courthouse and Grand Rapids Depot Commons.

A previous flag installation was made in February, 2008 when a joint powers agreement was signed between the Leech Lake Tribal Court and the District Court of the 9th Judicial District (Itasca County). At that time the Leech Lake Band of Ojibwe flag was installed as a "Legacy of Hope" inside the Itasca County Courthouse. We want to build upon this Legacy of Hope.

Our vision is that Grand Rapids is experienced as a welcoming place for Ojibwe people of all ages to live, visit, attend school, work and shop. Installing these flags is a visible sign within the community, and a next step in building bridges from our shared past to our shared future.

We are planning to involve young people along with Ojibwe and non-native people. In addition to the flag installations, there will be drum circles, traditional food and other activities.

We hope you can attend this ceremony and celebration, and request you contact Circle of Healing member Jim Woehrle, at 218-999-0801 or jimw@kootasca.org if you have any questions, or would like to be directly involved with planning for this event.

We would ask that this invitation be extended to the eight local Indian Councils in your district. Circle of Healing representatives will gladly meet with any interested Local Indian Councils during the month of July to discuss the project and ensure that their suggestions help guide this ground-breaking project. I anticipate meeting with the Tribal Council in the near future to talk more about this event, and to request your input and suggestions.

Circle of Healing

The Circle of Healing began meeting in August 2011, the result of attending *Why We Are Who We Are: Confronting the Past to Move Forward*, sponsored by White Earth Tribal and Community College. Group members have a shared desire to address the issue of Native American Historical Trauma, and resonate with the words of Lila Watson, Australian Aborigine:

"If you have come here to help me, you are wasting your time. But if you have come because your liberation is bound up with mine, then let us work together."

The group is open and meets monthly for shared learning and to build the cross cultural relationships and connections that lead the way to action. To date the group has focused its energy in two areas – building awareness about historical trauma in the dominant culture, and connecting Ojibwe kids to their culture.

2012 Activities

- Presented two breakout sessions on historical trauma at the IASC Multi District Day
- Co-hosted, along with Circles of Support, Anton Treuer at Davies Theaters
- Organized a three-day cultural canoe trip for high school students from the Bug O Nay Ge Shig, Deer River and Northern Lights schools
- Paved the way for a federal grant awarded to the MN Dept of Corrections to bring cultural awareness training to the probation end of law enforcement.
- Traveled to St. Paul to attend Healing the Hurt Reader's Theater

Projects identified for 2013/2014

- A more welcoming Grand Rapids includes the LLBO flag installation at Grand Rapids Chamber of Commerce Depot Commons building and outside the Itasca County Courthouse, Ojibwe signage at local businesses and a Welcome Center
- Bring the "Why Treaties Matter" exhibit to the Itasca Area

- Supporting the revitalization of the Ojibwe language specific activities to be identified
- Advocacy for the Bug O Nay Ge Shig School specific activities to be identified
